Approval of August 23, 2022, D7 Board Meeting. Approved as submitted.

Treasurers Report: Harlan will give a full report at the President’s Meeting.

New Business: Harlan agreed to head the Nominating Committee for the upcoming 2023-24 Executive Board. Voting takes place at the President’s Meeting on May 6, 2023.

Discussion Items:

1. Awards for 2022-23 League Play: Awards for 2022-23 League Play Will be given out the 1st Saturday in April. Presidents will be polled at the Feb. 4th meeting to see if they would like to award trophies to 1st and 2nd place teams in each division OR give pins to each player on the 1st & 2nd place winning teams.
2. Sub List for League Play: It was decided the Rules Committee needs to discuss how subs are requested for the League season. It was suggested that having one day between Div 2 & 3 play needs to be considered.
3. Proposal for Discussion: League Play Format (2023-24). Discussion followed on having Two Divisions of 9 Teams or 3 Divisions with 6 Teams.
 - a. 2 Divisions: 9 Teams, 18 Weeks of Play, each team would have 2 byes.
 - b. 3 Divisions: 6 Teams, 20 Weeks of Play, Each team plays each other four times. There would be no byes.
Division One: Top Six Teams-Wed. Play
Division Two: Bottom 3 from Div. 1 and Top 3 from Div. 2 play on Thurs.
Division Three: Remaining 6 Teams Play on Tuesday

Motion was made, seconded and approved to have Three Divisions for the 23-24 League Season. Seconded & carried.

Fundraiser: 7 Hills is having a fundraiser in the near future. Damage was done by a storm to their building and the owner requested the club pay a share of the repair cost. Also, it was brought up that teams may request Funds from the CSA Endowment Fund.
